b. Further stated the permanent absentee list has grown to over one thousand voters.

Lascoe stated she wanted to correct her article from The Gem Newsletter, the State August 4 primary ballot does not include the Library Board but does include the precinct delegates. Further stated the ballot includes the Millage Renewal for the Fire Department Equipment and Truck Replacement, Millage Renewal for the renewal for the Fire Department Operations and the Ray Township Public Library Millage.

Lascoe stated the Clerk's office will be open on Saturday, August 2nd from 8:30 am to 4:30 to obtain an absentee ballot. She stated the absentee ballots have been delivered and they will begin testing the tabulators and hope to mail out the absentee ballots by the end of the month.

Lascoe stated she contacted the Bureau of Elections regarding the annexation of property to the Village of Romeo. The Office of the Great Seal has not given final approval of the annexation. Further stated at this time it is in the review of the State agencies.

Lascoe thanked Rudich Farm for the donation of flowers around the Township buildings.

WHEREAS the County Treasurer of Macomb, as the foreclosing governmental unit, is seeking to implement a program under MCL 211.78g(8), and has provided written notice to the treasurer [of the local unit] via letter dated June 1, 2020 detailing the Treasurer's intent to implement the program and informing the Ray Township that they have the option to participate in the program;

WHEREAS the Ray Township has 21 days to provide written notice of participation in the program: and

WHEREAS MCL 211.78g(10) requires this governing body of Ray Township to pass a resolution approving the Ray Township participation in the PAYS program and to provide a written notice of participation to the Macomb County Treasurer via the Ray Township Treasurer.

NOW, THEREFORE, BE IT RESOLVED, that the governing body of Ray Township approves participation of the Ray Township in the PAYS program.
