GENERAL: ELECTRICAL work shall not be started until the application for permit has been filed. All installations shall be in conformance with the ELECTRICAL Code. **No work shall be concealed until it has been inspected.** When ready for inspection, call The Ray Township Building Department (586)749-5171, ext. 203.

Plans and specifications must be submitted when the wiring or alteration to an electrical system is over 400 amps and is in excess of 3, 500 square feet in all buildings.  
 What is the rating of the service or feeder in amperes? \_\_\_\_\_ What is the building size in square feet? \_\_\_\_\_  
**PLANS ARE NOT REQUIRED FOR THE FOLLOWING:**  
 1. When the electrical system rating does not exceed 400 amps and the building is not over 3,500 square feet in area.  
 2. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.  
**PLANS ARE REQUIRED** for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act. No. 299 of the Public Acts of 1980, as amended, and shall bear that architects or engineers signature and seal.  
**PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.**
