b. Fire Hall – Insurance Claim

Lascoe stated she would be abstaining from the item since her husband works for Jarvis Property Restoration.

Jarzyna stated the item was tabled to obtain estimates from Solid Barn, Orchard Construction and Master Construction. He stated none of the companies are interested in doing the repair work. He stated two bids were received, Jarvis Property Restoration totaling \$6,906.79 and Montgomery & Sons, Inc. totaling \$6,583.73. He stated Jarvis Property Restoration stated they would waive the Townships \$1,000.00 deductible.

MOTION by Stier supported by Grader to accept \$6,906.70 for repair of trusses at the Ray Township Fire Hall with the waiver of the \$1,000.00 deductible.

Abstained: Lascoe MOTION carried.

11.NEW BUSINESS

a. Request to have Zoning Ordinance 36 converted in Municode database and website.

Lascoe explained the zoning ordinance is not up to date with all the zoning ordinance amendments. The amendments are listed on the Township website but should be incorporated into the document. She explained the amendments cannot be inserted because the Township does not have the In-Design software which is costly and would require training. She stated most communities use Municode with a search capacity and a link from the Township website to Municode, they would insert all amendments. She stated Municode has provided two options for publication but only one options has a search capability. Municode would not include the Code of Ordinances which can easily be updated in the office and is available on the Township website.

Grader asked the cost for the amendments.

Lascoe stated \$18.00 per page for any new amendments.

MOTION by Bohm supported by Stier to accept the bid of \$1,475.00 from Glefke and Sons for the Tree Removal and Stump Grinding.

d. Library request for Children's Garden Area.

Library request permission to create 10'X10' Children's garden area.

MOTION by Grader supported by Bohm to approve Children's Garden Area upon contact with insurance company to verify this will not be a liability.

MOTION carried.

e. Simplex Fire replace Sensors

Stier stated the fire alarm system needs to be upgraded.

MOTION by Stier supported by Lascoe to accept Simplex Grinnell quote of \$2,320.00 plus shipping if necessary to install three wireless smoke detectors and reprogram existing DSC fire alarm system. MOTION carried.

12. PUBLIC COMMENTS:

Kevin Brown, 18955 29 Mile Road, asked if there is an ordinance regulating garage sales. He stated there is a continuous sale on 29 Mile Road that creates a hazard for parking along the major road. Further asked the status of how the business in residential districts are progressing.

Jarzyna advised that many were Type 1 home occupations and are still being reviewed.

Terry Goike, 21122 32 Mile Road, thanked the Board for approving the \$500.00 contribution to the Library. She thanked the Fire Department and everyone who donated to the Trunk to Treasures event. She stated the weather was not good, but the library did raise some funds.
