Bill Kehrer, 20015 30 Mile Road, stated a Township Board Meeting was held on May 3, 2018 at 1:00 p.m. where the Township Board discussed using \$200,000.00 of taxpayer dollars to fund a sewer connection with Shelby Township. He questioned why the meeting was held at 1:00 p.m. in the afternoon? He stated only three residents were in attendance and the meeting should have been held in the evening. Further stated the Township Board stated for years that taxpayer dollars would not be used for sewer connections.

7. OFFICER'S REPORTS

- a. Supervisor Jarzyna stated the Macomb County Bicentennial Torch Run is coming through Ray Township on Thursday June 21, 2018 at approximately 4:00 p.m. He stated it will start at Ray Center and the torch will be handed off in Lenox Township.
- b. Clerk Lascoe stated on May 29, 2018 we were reimbursed from the Macomb Community College for conducting the special election. Payment was \$3,326.36.

Lascoe stated the absentee applications were mailed on Tuesday, June 12 – if anyone would like an absentee ballot, they should contact the Clerk's Office. She stated the ballots were just delivered and the ballots will be tested before the absentee ballots are issued. She reported Monday, July 9th, 2018 is the last day to register to vote for the August 7th, primary election. Further stated the Clerk's Office will be open on Saturday, August 4th from 9 am to 2 p.m. to obtain an absentee ballot.

Lascoe reported on Monday, June 18, 2018 we received payment of \$5,000.00 from CDBG for the library ADA door.

- b. Treasurer Stier stated the delinquent tax check has been received from the Macomb County Treasurer. Ray Day is this Sunday on June 24, from 12 p.m. to 4 p.m. currently there are 19 prizes. He stated a new resident visited the office today and returned later in the day with a donation of two more new bikes and helmets.
- c. Trustee Grader asked when the 28 Mile Road bridge would be open. Jarzyna advised the end of June. She asked when will the phragmite spraying begin. Jarzyna advised August and September.
- d. Trustee Bohm asked if the Macomb County Road Commission had begun removing the phragmites? Bohm replied to Mr. Kehrer's public comment regarding the May 3, 2018 special Board meeting. He explained at the special meeting the Township Board was given a presentation by the engineer and the professionals presented options regarding sewer and wastewater treatment plant.

9. UNFINISHED BUSINESS

a. Consent Judgment for Four Star Development for proposed sewer connection to Shelby Twp. Jarzyna stated he and Trustee Bohm attended a meeting with the Macomb County Public Works after the May 3, 2018 special meeting. He explained Ray Township is required by the consent judgment to try and work with another municipality to provide a sewer connection for the Four-Star development in lieu of a wastewater treatment plant. The \$200,000.00 cost to connect to Shelby Township will be the cost to upsize the pipe from 15" to 18" North of 25 Mile Rd and extend to 26 Mile Rd. The \$200,000.00 will be returned

A wastewater treatment plant will in time become the townships financial responsibility. Further stated the meeting was held in the afternoon based upon the availability of the professionals making the presentation.

Bohm advised at the Public Works meeting many options were discussed and no decisions have been made. MOTION by Bohm supported by Grader to table item 10a.) Consent Judgment for Four Star Development for proposed sewer connection to Shelby Township.

11. PUBLIC COMMENTS:

Paul Kowalewski,63011 Indian Trail, stated he owns 2.93 acres, with 392' of frontage on Indian Trail and 400' of frontage on 29 Road. He stated he would like to build a pole barn on his property but due to the Zoning Ordinance setback requirements he is unable to use 1.5 acres of his property that is the designated right-of-way. He stated he is expected to maintain and pay taxes on the 50' setback and would like to use the area to construct a pole barn. Further requested the Board to allow him to construct the pole barn as requested.

Jarzyna explained the Board cannot grant a variance and he would need to apply for a variance request from the Zoning Board of Appeals.

Valerie Matusz, 16741 29 Mile Road, inquired if she could have statue in her front yard.

Kevin Brown, 18955 29 Mile Road, stated he appreciates the Supervisors explanation regarding the special meeting for the proposed sewer connection with Shelby Township. He stated based on Jarzyna's explanation it is in the best interest of the Township to go with the sewer. Otherwise the Township and taxpayers will be responsible for the wastewater treatment plant.

Jarzyna stated the meeting was set up by the township engineer.
