EXPIRATION OF PERMIT

<p>A permit will expire and become null and void if work is not started within 180 days, or if work is suspended or abandoned for a period of 180 days after work has commenced. PERMITS ARE VALID FOR 12 MONTHS FROM DATE OF ISSUANCE. A PERMIT REMAINS VALID AS LONG AS WORK IS PROGRESSING AND INSPECTIONS ARE REQUESTED AND CONDUCTED.</p>

24-HOUR NOTICE IS NEEDED FOR ALL INSPECTIONS. INSPECTIONS WILL ONLY BE ACCEPTED DURING REGULAR BUSINESS HOURS. WORK STARTED PRIOR TO OBTAINING A PERMIT ARE SUBJECT TO CHARGES OVER AND ABOVE THE PERMIT FEES.

GENERAL: ELECTRICAL work shall not be started until the application for permit has been filed. All installations shall be in conformance with the ELECTRICAL Code. **No work shall be concealed until it has been inspected.** When ready for inspection, call The Ray Township Building Department (586)749-5171, ext. 203.

Plans and specifications must be submitted when the wiring or alteration to a residential electrical system is over 201 amps. Electrical plans are required for residential over 3500 square feet.
 What is the rating of the service or feeder in amperes? _____ What is the building size in square feet? _____
PLANS ARE NOT REQUIRED FOR THE FOLLOWING:
 1. When the electrical system rating does not exceed 200 amps and the building is not over 3,500 square feet in area.
 2. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.
PLANS ARE REQUIRED for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act. No. 299 of the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal.
PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.
