Care House requested \$1,200.00 of CDBG service funds.

Jarzyna stated he met with the GFL Representatives regarding curbside recycling. He explained GFL will send out a flyer to all residents in March informing them of the cost for curbside recycling would be \$8.00 per quarter for each household. Further stated a 65-gallon recycling container will be available at a cost of \$45.00.

b. Clerk Lascoe reported the Planning Commission had a meeting on January 12, 2020 for a special land use and site plan for Youngblood Winery. Further stated the item was tabled for the Township Attorney to review the Right to Farm Act and the Township Zoning Ordinance.

Lascoe reported the Governor has called for a Special Primary Election to be held on August 3, 2021 and November 2, 2021 Special Election for the purpose of filling the vacancy that exists in the Senate caused by Senator Pete Lucido as elected the Macomb County Prosecutor.

Stier stated according to the State of Michigan statute and the MTA, 5,000 residents or 3,000 electors.

Lascoe stated the Township has 3,200 registered voters. Further stated the item could be on the next election in November of 2022.

Grader stated as I understand the Board may consider adding two additional trustees.

Jarzyna stated in a Township having a population of 5,000 or more or having 3,000 or more qualified registered voters may add two more trustees based on a response to a specific ballot question at the next general election or at a board of electors meeting. He stated the Township does not have a Board of Electors meeting. He explained the surrounding Townships which have a population over 5,000 all have five member boards. He stated Armada Township has a population is 5,379 with 29 mils, Bruce Township population is 8,770 with 30 mils, Ray Township has a population is 3,739 with 25 mils and Lenox Township has a population is 11,339 with 30 mils. He questioned if a ballot proposal was put on the 2022 election to add two more trustees, where would the money come from to pay for two additional trustees?

Stier stated the pay would be from the beginning of the term and would be in four years.

Jarzyna stated no, it would be in 2 years. He stated two additional trustees would be another \$12,500.00 annually in wages. He stated the SEV's of the surrounding communities are as follows: Armada is 420 million, Bruce is 683 million, Lenox is 415 million, Richmond is 243 million and again they are all five member boards.

Lascoe stated the Board would set the wages for four trustees.

Grader stated she has reviewed the information, considered the question, and feels the Board has done a great job of representing the Township. She felt it is in the Townships best interest to keep it as a five member board.

She stated she is looking to switch from PNC Bank to Huntington Bank and they have suggested the revisions to the existing policy as presented to the Board. Further a Resolution for the Credit Card Policy is required.

MOTION by Lascoe supported Grader to amend the Credit Card Policy and to adopt Resolution 2021-5 Credit Card Policy, as follows:

WHEREAS: Township of Ray adopted a Credit Card policy in compliance with Michigan Public Act 266 of 1995, MCLA 129.243, et seq. on January 19, 2021 and;

WHEREAS: Township of Ray has identified a need to update the existing policy to reflect current business practices and the operating environment;

NOW THEREFORE BE IT RESOLVED: That the Township of Ray does hereby adopt the following updated Credit Card Policy:

- a) Under direction of the Treasurer, Betsy Bart (or the Deputy Treasurer, in the Treasurer's absence), is designated as the position responsible for credit card issuance, accounting, monitoring, setting individual credit limits, retrieval and overall compliance with the credit card policy. New users shall be authorized by the Treasurer.
- b) Any credit card issued to the Township of Ray may be used by an officer or employee of the Township of Ray for official Township business purposes only. The card may not be used for private expenses or to withdraw cash (cash advance).
- c) An officer or employee using a credit card issued to the Township shall submit documentation, as required by the financial review processes of the Township, to validate the official Township business purpose of all such expenditures. The card holder is responsible for timely reconciling the monthly credit card statement and for providing adequate documentation for expenditures incurred prior to submitting for financial review and payment. Documentation must include a copy of the invoice or receipt that includes the payee name, date and amount of expenditure, and proof of payment, and must be accompanied by the business purpose for the expenditure. Expenditures for meals, meetings, training and education, travel or similar expenses must identify those involved in accordance with Internal Revenue Service guidelines.
- d) An officer or employee issued a credit card is responsible for its protection and custody and shall immediately notify the issuing agency and the Director of Fiscal Services if the credit card is lost or stolen. Protection and custody applies to the physical card as well as the specific account information; credit card data is not permitted to be stored on external servers, websites, etc. The cardholder is ultimately responsible for the safekeeping and appropriate use of the corporate credit card and must read and sign the Township's Cardholder User Agreement acknowledging acceptance of his policy. Individuals who fail to adhere to these policies and procedures risk revocation of their credit card privileges and/or disciplinary action.
- e) The internal controls, monitoring, accounting, and payment of credit card charges shall be the same as those in place for noncredit card purchases of goods and services. Use of the Card is subject to the guidelines of the Township's Corporate Credit Card, Travel Policies, and current Township procurement processes and procedures.
- f) Unauthorized use of a credit card by an officer or employee of the Township shall subject them to disciplinary measures consistent with law and the personnel policies of the Ray Township up to and including termination of employment and/or prosecution. The Township shall be entitled to recover any and all expenditures related to misuse of the credit card, including failure to timely reconcile card holder expenditures, through payroll deductions for any unsupported amounts incorrectly claimed.
- g) The corporate credit card is the property of the Township, an officer or employee issued a credit card shall return the credit card to the Township with a final reconciliation and receipts of all expenditures upon the termination of his or her employment or official service to the Township.
- h) Payment of all credit card invoices is subject to the internal accounting controls and expenditure review process of the Township.
- i) The balance including interest due on an extension of credit under the credit card arrangement shall be paid within not more than sixty (60) days of the initial statement date. However, the card holder shall be responsible for any late fees or accrued interest related to their use of the corporate credit card and shall reimburse the Township through payroll deductions for such amounts.
- j) Credit card arrangements currently exist with VISA and MasterCard to facilitate payment for various services provided by Township departments including, but not limited to, Parks and Recreation programs, payment for database searches and other specialized services provided by the Library, and payments to the Township for a tax, assessment, or fee in accordance with Public Act 280, of 1995, M.C.L.A. 129.221, et seq.
