a. Spark Grant program for two pickleball courts proposed in the Township Municipal Park

Treasurer Betsy Bart explained Michigan Township of Association announced the Sparks grant includes the development, renovation or redevelopment of public recreation at public recreation space that have been adversely affected by the COVID-19 pandemic. She stated residents have expressed their desire for pickleball courts in the Township park. The Sparks grant is a total of \$65 million, the grant amounts that will be awarded is one-hundred thousand to one million dollars. She contacted Steve Cassin; the Township Planner and he prepared the plan that was provided to the Board of the Park showing the area south of the basketball & tennis area for two pickleball courts. She provided the Board with a quote from Snapsports for two pickleball courts at 60' x 30' for \$32,250.00 which would still require the base of asphalt. She explained Doug Stier contacted Total Asphalt Paving for a quote for the asphalt and they submitted a complete quote for two pickleball courts which included the entire project at \$68,250.00 which includes the fence, poles, net, and striping.

Jarzyna stated he reviewed previous grants and twenty-five percent was provided so he recommended providing \$25,000.00 for the project.

Lascoe stated the Spark grant is offered by the State Department of Natural Resources. Further stated she has read in the paper of other municipalities applying for the grant.

Bart stated the total project with the Townships portion would be \$125,000.

Stier asked if the tennis court/basketball area could be revamped.

Bart stated the basketball/tennis area is used in the park.

Grader stated it would be wonderful if the Township received the grant and was able to provide two pickleball courts and re-do the tennis/basketball area.

MOTION by Lascoe supported by Jarzyna for Treasurer Betsy Bart to submit the Spark Grant for two pickleball courts proposed in the Township Municipal Park.
