4. NEW BUSINESS

a. Fire Dispatch Service Proposal

Chief Hoskin stated the Board toured the COMTEC facility to see the full-service dispatch services provided. The Board received the Macomb County Sheriff's Office Dispatch Service Proposal that was prepared for Ray Township. He stated the Township alerts are delayed four to five minutes currently and in an emergency every minute counts. Further provided the start-up costs for COMTEC including the hardware and hardware start-up costs for equipping, installing and training the personnel and vehicle installation, station outfitting, the Samsung Galaxy Active 4 PRO tablets and the AT&T monthly charge which can be adjusted to the data use.

Angela Elsey, Dispatch Director of COMTEC explained the benefits for the Fire Department in utilizing the professional services for dispatching for all 911 calls which provides the services, networking hardware and network connectivity, computer hardware, software licensing costs, software maintenance costs and support services costs. She explained the dispatch service provides alerts and updates with direct connectivity in the vehicles and tablets so there is no missed communication, as the software routes the address direct. Further explained all mutual aid surrounding communities receive the alerts.

Supervisor Jarzyna stated Treasurer Bart has provided the accounts the funds would be expensed. Further stated the Township Attorney and the Township Auditors stated the fire funds are for the equipment and operating of the Fire Department.

Discussion was held on the costs for the equipment and the annual costs for 2023-2024.

She recommended the lowest bidder be awarded the contract which was Unique Clips for the Township Hall and Library mowing including trimming and bi-weekly edging for \$45.00 per cut with the Spring Clean-up for \$135.00 and \$190.00 for Fall Clean-up. For the Municipal baseball diamonds and park the mowing including trimming and bi-weekly edging \$290.00 per cut, \$580.00 for Spring Clean-up and \$870.00 for Fall Clean-up. For the Fire Department the mowing including trimming and bi-weekly edging for \$45.00 per cut along with the spring clean-up for \$135.00 and \$190.00 for the fall clean-up.
