New Haven Community Schools Bond Proposal

Shall New Haven Community Schools, Macomb County, Michigan, borrow the sum of not to exceed Forty-Three Million Six Hundred Sixty Thousand Dollars (\$43,660,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of:

remodeling, furnishing and refumishing, and equipping and re-equipping school buildings; acquiring, installing, and equipping and re-equipping school buildings for instructional technology; erecting and equipping an athletic concession building at the middle school and a bus garage; purchasing school buses; and preparing, developing, improving, and equipping playgrounds, athletic fields and facilities, and sites?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2024, under current law, is -0-mill (\$0 on each \$1,000 of taxable valuation) for a -0-mill net increase over the prior year's levy. The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-five (25) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 1.09 mills (\$1.09 on each \$1,000 of taxable valuation).

The school district expects to borrow from the State School Bond Qualification and Loan Program to pay debt service on these bonds. The estimated total principal amount of that borrowing is \$5,383,496 and the estimated total interest to be paid thereon is \$2,982,658. The estimated duration of the millage levy associated with that borrowing is eight (8) years and the estimated computed millage rate for such levy is 8.26 mills. The estimated computed millage rate may change based on changes in certain circumstances.

The total amount of qualified bonds currently outstanding is \$54,005,000. The total amount of qualified loans currently outstanding is approximately \$16,023,588,
