\_\_\_\_ **Planning Commission** meets on the second Tuesday of each month at 7:00 p.m. at the Township Hall. It holds hearings when appropriate and reviews development plans and makes recommendations to the Township Board with regards to zone changes, special uses, and zoning ordinance amendments. The Commission consists of seven (7) members who are appointed by the Township Board. An appointment to this Commission is a three (3) year term.

\_\_\_\_ **Zoning Board of Appeals** meets as needed on the fourth Tuesday of the month at 7:00 p.m. at the Township Hall. It holds meetings for hearings and takes action regarding requested variances to the zoning ordinance and appeals. This Board consists of five (5) members who are appointed by the Township Board. An appointment to this Board is a three (3) year term.

\_\_\_\_ **Board of Review** meetings take place at the Township Hall and are set by State Statutes in March, July and December to hear protests of assessed and/or taxable values of real and personal property, to assure that all non-exempt property has been assessed at 50% of the true cash value and uniformly assessed with other properties in the classification and to correct clerical errors and omissions. This Board consists of three (3) members and one (1) alternate who are appointed by the Township Board for a two (2) year term.

\_\_\_\_ **Recreation Committee** is responsible for planning, directing and monitoring community recreation events such as the Easter Egg Hunt, Ray Day, Trunk or Treat, and Tree Lighting. Hours will depend on the events being planned. This committee consists of one (1) leader and five (5) members who are appointed by the Township Board. An appointment to this committee is for a two (2) year term.
